What's New

Client

Client information

- The date of the earmould issue is now shown on the Client Information - Devices tab to avoid having to open the Earmould dialog to access this.
- PAS Update is more strict in cases when a different patient identifier is returned and a patient with that identifier exists. Working with the existing patient only will be allowed to reduce the risk of duplicate patients being created.
- Patient primary identifier mask and length settings have been improved for easier configuration with a new separate setting for length of Temporary number.

Client search

- Searching for clients on the F3 dialog without specifying any criteria can be prohibited in the Administration tool to conform with interpretations of patient information rules.

Communication

Task list – optional feature

- Task deletion is now permanent, irrevocable deletion
- Users will be warned that they are deleting and how many tasks will be deleted
- Deletion of tasks others than made by yourself is now only possible when the user has an Extended right
- When a Client related task is deleted before it is Completed an Auto Journal Event can be generated to record the deletion
- We've made several improvements to the Task List module to support users' workflows.
- All the existing Task List Auto Journal Events have been improved by adding the Task description
- You can now filter the Task List to show just the current client's Tasks
- The filter options used in the Task List will now be memorized for the user

- When you change the client on the Task list you now receive a warning
- You can now use Shift and Control buttons to easily make multiple selections and then Complete or Delete them

Earmould dialogue

- The Earmould module has changed to reflect users moving to a workflow where they choose the mould manufacturer before choosing the type and material
- Earmould types and materials can now be optionally linked to Manufacturer so that only relevant types and materials are shown after the manufacturer is selected.
- The Earmould dialog layout has been modified to reflect the ability to filter types and materials by manufacturer.
- The Earmould dialog size has been increased for improved readability
- We've made various improvements to the Earmould module to support users' workflows.
- The patient Location is now shown on the Earmould List to allow sorting of patients by Location. This can be disabled if not required as it could lower List population speed.
- 'Centre number' can be modified when an earmould record is being made allowing users to specify that the mould should be delivered to a more local centre for the patient. The Centre number will now be stored when the earmould record is stored, rather than when it is printed.
- The Earmould Search dialog size has been increased to both see more results and more easily see the results.
- Earmoulds that have been issued can be excluded from the Earmould List, allowing you to narrow the results to earmoulds that have yet to be issued out.

- The Document List will now be refreshed after creating a new Document

User reports

- Two new reports have been added to overview appointments by their status filtered by dates and grouped by appointment type and resources

Technical foundation

- A new Team Developer patch has been included to resolve some underlying bugs
- Old C++ runtimes have been removed
- Database traffic can now be encrypted using TLS 1.2 or 1.3 encryption level

System Administration

General

- The Stock 'Sales price' option which allows you to add a % to purchase price is moved from workstation
- Application default printer concept has been removed in order to make it easier to see which printer type any given report will print to.
