Client information

- We have added support for the Swedish National Reserve Identifier
- We have added new configuration options to define what can be viewed and what is mandatory, to be set at the site and individual user levels.
- Hide unwanted tabs in Client Information module
- Hide unwanted fields in the Client Information Details tab
- Mandatory Client fields as well as last name which is already mandatory now first name and date-of-birth can be required
- We've added a new tab for 'Record info' to show when a client's record was created and whether they originated from a merge or conversion
- New gender values of Non-Binary and Not applicable have been added to the list of available values

- We've introduced better separator handling for export reports to Crystal Format
- For administrators managing Ear surgeries we have introduced a new user report to make it easier to overview where patients are on their progress through assessment and treatment stages.

Audiogram

- Audiogram static norm curves can now be defined in Auditbase Administration, a specific curve can be selected for a specific workstation
- Based on data from ISO 7029 you can now display age and gender specific dynamic hearing loss distribution percentile curves. The percentile value used can be chosen in Auditbase Administration on a site level
- We have added a choice of whether male, female or no percentiles should be shown in the Audiogram module when on a specific client. This allows a client with one stated gender to use percentile values calculated for their sex at birth.
- We have added new configuration options to define what can be viewed and what is mandatory, to be set at the site and individual user levels.
- Hide any of the tabs in Audiogram module, except 'Information'
- Set the 'Audiogram type' as a mandatory field for saving a record

Audiometer and tymp interfaces

- Tymp ID can now be edited manually to make it possible to record the Tympanometer details when using different tymps in the same room.
- Where a Noah Tymp module requires it curve compensation can now be applied even when it is declared as already applied in the measurement.
