## What's New

## Client

#### Alerts

• The user who created a client Alert or Parameter along with the date it was created are now shown on the Client's list, making it easier to keep alerts current and accurate

#### **Client information**

• Ventilation size is now shown on the Earmould section of the Devices tab on Client Information for a fast and easy overview of this key earmould attribute

#### **Client merge**

• When selecting two clients for merge the user will be alerted if a Client is currently selected by another user in order to prevent a loss of data if a user is saving a record while the merge is taking place

#### **Client search**

• A new Clear button on the F3 Search dialog allows multiple searches to be made one after another without clearing the parameter fields manually

## **Clinical records**

#### COSI

- COSI average scoring and reporting
- Average COSI score is now calculated allowing patient's COSI scores to be more easily compared using this NAL approved summary score
- A new report on COSI shows the average scores across patients, allowing the comparison and collation of data and outcome measures from the department to inform commissioners, potentially with reference to NAL reference data
- A new report on COSI shows the improvement, percentages and distribution of patients having responses to the NAL categorised situations to provide analysis of outcomes with reference to standard situations

## Hearing instrument related

#### Earmould dialogue

• Earmould statistics can now be exported to CSV for analysis in Excel

• In the Earmould List dialog you can now show all earmould orders with impressions between certain dates but without a Ready date. You can then set multiple ones Ready in one click, saving a lot of time when processing a new batch.

#### Stock

- Discontinued articles can now be hidden when registering quantity-controlled items to make using the dialog easier
- When the user has had their full name or professional title changed in Administration using the "User title and name history" feature the name and title in use when they made any stock transaction is the one that will be seen.

### Letters, attachments and reports

#### **Documents and attachments**

• Old duplicated Letter and document variables have been removed from the Word variable list but will still work in existing letters

#### User reports

• A new report can be used to identify how referrals from any GP or other Referrer are trending up or down over a given period, helping to manage your relationships with Referrers

#### Measurement and clinical

#### **Auditory Implant Module – optional**

- Implant Module Rehabilitation and Programming forms can now be signed to lock them in accordance with HCPC and RCSLT professional guidance
- When Implant Module Rehabilitation and Programming forms are signed to lock them an Auto Journal Event can be triggered so that milestone can be viewed from the Journal
- New variables are now available for Word documents and letters consisting of the key Implant dates shown on Client Information such as first and latest surgery and switch-on dates
- New variables are now available for Word documents and letters consisting of the key BKB results, with the ability to select which test instance to include in a dialog that shows the key condition information
- Audiogram images are now shown in the Implant module Pre-op Assessment printout to give a more visually useful report
- The Implant Module Switch On/Review form now includes 'Transfer in' as a 'Purpose' of the event so the record of a transfer review can be properly seen
- More than seven electrodes can now be recorded on the Implant module Programming form due to a change in user requirements

- 'Hearing Aid' has been added as a Processor type on the Implant module Programming form to record the aids that work in conjunction with processors
- Values with decimal places can now be saved on the Adaptive BKB, Automated Toy, CELF and PLS tests

## **Other features**

#### **Attention list**

- The Treatment Type has been added as a column to the Referral tab in the Attention List to make the Referrals listed easier to identify
- The Referral tab on the Attention List has an improved algorithm and faster performance for a better overview of Referrals that have never had an appointment or waiting list attached to them

#### Laptop synchronization

• Noah actions including fittings and REMs performed on a synchronising laptop are now linked to appointments after synchronisation. This allows AQP and other quality of service reporting to include all REMs made on synchronising laptops

## Scheduling

#### Booking

- A 'Declined offer" of appointment can be recorded quickly in Booking and shown in the Clients Entries while leaving the Booking slot free to record for reporting that the dept. has made every effort to book the patient before any target milestone dates
- The Timeplan view window size in Booking can now be altered by sliding the divider between upper and lower areas to fully customize the user's view, particularly for larger screens
- The "Booking List" report now includes patient phone numbers to easily contact them from the sheet when used out of office or in a planned IT outage

#### **Referral pathway**

- Clients Waiting List entries are now prohibited from being attached to Closed Referrals to ensure users open a new Referral when required
- The content of the Referral module drop down list of existing Referrals now includes Treatment Type for a more informative overview to speed up selection of the correct Referral

#### **System Administration**

- AuditBase Administration has been redesigned for faster and easier work
- A new upper level grouping has been introduced to categorise pages logically allowing them to be found more easily
- A 'find' and 'find next' search function has been added to find all folders and pages named with a search word to quickly find the topic you need
- The grouping tree can be hidden and auto-hidden maximizing your workspace
- All Client related configurations are now grouped into a Client Settings group for easier access
- All Referrer and Customer related configurations are now grouped into a Referrers group
- Customers and Customer Groups configurations are now moved out of AuditBase and into the Administration tool in the new Referrers group. Existing users can be given the Extended Right to configure the new page in Administration
- CCGs can now be outdated to allow cleaning up of old values
- Customers and Customer Groups can now be outdated to allow cleaning up of old values
- Referral and Appointment Outcome statuses and their attributes and paired statuses can now be exported to Excel to facilitate pathway design and training

#### User setup, rights and maintenance

- Permanent patient deletion for GDPR now has a separate Extended right from reversible patient delete to allow different users to have the different delete level permissions
- When a new Resource is created it is now added automatically to every user's Resource view even when they have changed it from the default setup making the creation of new Resources much smoother to distribute through the dept.
- Users can now have their Login name changed by the System Administrator, in the case of marital name change for instance

## Views and Navigation

#### Navigation

• The appearance of the Navigation pane is now retained after logging out of AuditBase using F2
